INSTRUCTIONS FOR ADMISSION TO PRACTICE IN THE  
UNITED STATES DISTRICT COURT FOR THE  
MIDDLE DISTRICT OF TENNESSEE

Attached is an application to practice before the United States District Court for the Middle District of Tennessee.

Before you can be admitted to practice in this District Court, you must complete this application and submit it to the Clerk's Office for approval. Make certain that the two attorneys who sign the application on your behalf are admitted to practice before this Court.

After you have submitted your application to the Clerk's Office, we will promptly determine if your application may be approved pursuant to Rule 1 of the Local Rules of this Court. If we approve your application, you will receive a letter of approval. **You must be admitted to practice within six (6) months from the date your application is approved.**

After you receive a letter of approval, please call (615) 736-5498, ext. 205, prior to making your plans for the introduction so that we can arrange a time and date for you to be introduced.

Before you may be admitted and after your application has been approved, an attorney who is admitted to practice before this Court must accompany you and introduce you in open Court. This attorney does not need to be one of the attorneys who signed your application for admission. Normally the introductions are handled as preliminary matters any day at 9:00 a.m. or 1:00 p.m., but you must call the Clerk's Office prior to scheduling a time for your introduction to make certain that a judge will be available to grant your motion for admission.

On the day scheduled for your admission, please report to the Clerk's Office at least fifteen minutes prior to the time you are to be admitted.

After the judge admits you to practice, you must return to the Clerk's Office to pay the \$65.00 admission fee, sign the Bar book, and receive your certificate to practice.

You must follow all the steps outlined above to be a member of the Bar of this Court. Please call Patsy Flowers at (615) 736-5498, ext. 205, if you have any questions about our procedure or if we may be of assistance in any way.
