- A. After the *Petition for Adoption* is granted, the adoption can never be set aside or changed because a party to this agreement fails to follow its terms.**
- B. After the *Petition for Adoption* is granted and this agreement is approved by the court, if the parties disagree or a party files a *Petition for Enforcement, Modification, or Termination of Postadoption Contact Agreement* (form ADOPT-315), the validity of the adoption will not be affected.**
- C. After the *Petition for Adoption* is granted and this agreement is approved by the court, if the parties disagree, no party may file a *Petition for Enforcement, Modification, or Termination of Postadoption Contact Agreement* unless the party proves to the court that he or she has participated, or attempted to participate, in good-faith mediation or other appropriate dispute resolution.**
