- C. said child/youth is in immediate physical danger from surroundings.

AND

As a result of said conditions, the child's/youth's safety is endangered and immediate removal from such surroundings is necessary to ensure the child's/youth's safety.

- II. Conditions or circumstances surrounding the care of said child/youth require that the respondent(s) appear before the court as set forth below to determine whether an order vesting temporary custody of said child/youth in a suitable agency or person should be issued pending disposition of the petition.
- III. Continuation in the home is contrary to the welfare of said child/youth.
