INSTRUCTIONS

This form is to be used under:

MCL 750.520m to order the defendant/juvenile to provide samples of his or her blood for chemical testing for DNA identification profiling or a determination of the blood's genetic markers and shall provide samples of his or her saliva for chemical testing for a determination of the secretor status of the saliva when a defendant/juvenile is convicted of/found responsible for a violation or attempted violation as specified below.

PERSONS SUBJECT TO DNA IDENTIFICATION PROFILING UNDER MCL 750.520m

1. If a defendant is charged with violations of and convicted of one of the following offenses, a DNA sample is required:
2. If a juvenile is designated or jurisdiction of the juvenile is waived to circuit court for violations of and the juvenile is convicted (as an adult) of one of the following offenses, a DNA sample is required:

MCL various	Any felony or attempted felony
MCL 750.145a	Enticing a child for immoral purposes (includes ordinance violations)
MCL 750.167	Disorderly person by window peeping, engaging in indecent or obscene conduct in public, or loitering in a house of prostitution (includes ordinance violations)
MCL 750.335a	Indecent exposure (includes ordinance violations)
MCL 750.451	First and second prostitution (includes ordinance violations)
MCL 750.454	Leasing a house for purposes of prostitution (includes ordinance violations)
MCL 750.462	Female under age of 17 in a house of prostitution (includes ordinance violations)

3. If a juvenile is being processed as a juvenile in the Family Division and has been found responsible for one of the following offenses, a DNA sample is required:

MCL 750.83	Assault with intent to commit murder or attempted
MCL 750.91	Attempt to murder
MCL 750.167	Disorderly person by window peeping, engaging in indecent or obscene conduct in public (includes ordinance violations)
MCL 750.316	First degree murder or attempted
MCL 750.317	Second degree murder or attempted
MCL 750.321	Manslaughter or attempted
MCL 750.335a	Indecent exposure (includes ordinance violations)
MCL 750.349	Kidnapping or attempted
MCL 750.520b	First degree criminal sexual conduct or attempted
MCL 750.520c	Second degree criminal sexual conduct or attempted
MCL 750.520d	Third degree criminal sexual conduct or attempted
MCL 750.520e	Fourth degree criminal sexual conduct or attempted
