3. That I (we) have not had any permit or license to sell nonintoxicating liquors revoked in any county of this state for the past twelve (12) months.
4. That I (we) have not held, nor do I currently hold, a retail liquor dealer's permit or license from the United States government to engage in the sale of intoxicating liquor.
5. That no permit or license to sell nonintoxicating liquor has been issued by the United States government at the address stated above.
6. That the location is not located within three hundred (300) feet from any public school or church property primarily and regularly used for worship services and religious activities.
7. If the applicant(s) is (are) incorporated, that the corporation is duly authorized to transact business in the State of Oklahoma; and that the agent or employees managing or in charge of the place of business for which the permit is sought are maintaining and residing in a residence located in the licensing county, or an adjoining county; and that the corporation consists to the service of any and all notices required to be served pursuant to 37 O.S. §§ 163.1 et seq. upon the resident agent or employee.
8. If the applicant(s) is (are) not incorporated, that each applicant for the permit or other individual having a beneficial interest in the business for which a permit is sought, has for at least one (1) year next preceding the filing of the application maintained a bona fide residence in the State of Oklahoma, and is at the time of making the application maintaining and actually residing in a residence in the county, or adjoining county, in which said application is made.
