This form is used by a Fiduciary to file an accounting with the Court. Every Executor, Administrator, Guardian or Conservator is required to file an Accounting of his/her receipts and expenditures with the Probate Court.

- However, Administrators or Executors may file **Form PC-7.3, Affidavit of Complete Administration**, in lieu of such Account.
- This must take place annually after first publication of qualification and at least once a year thereafter, as long as the Estate remains open.
- Closing of estate may take effect 6 months after first publication of qualification.

The Fiduciary presents to the Probate Court the completed form:

Schedule A -

- Enters all amounts received by Fiduciary following inventory or prior account, such as interest on savings accounts, gain on sale of personal property, assets discovered following filing of inventory or prior account, amount received from sale of real estate, if any.

Schedule B -

- Enters payments, losses, charges and distributions.

Schedule C -

- In a first, second, third, etc. account, enters the amount of the balance remaining in the estate.
- **If page 1 of this form, is a Final Account**, enters the amount Zero.
 - Attaches completed **Form PC-7.2, Certification of Accounting**.
 - Attaches completed **Form PC-7.4, Application for Approval of Fiduciary's Fees**.
